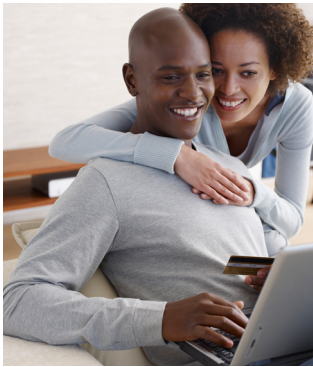

Online will preparation allows you to document your final wishes, including naming:

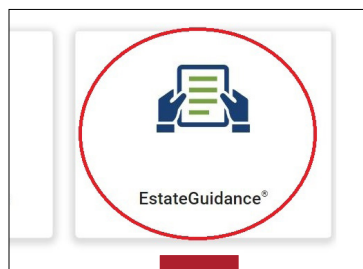
- Beneficiaries to inherit property

- Make unlimited revisions at no cost.

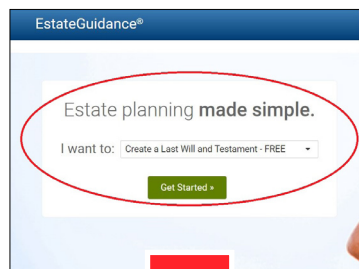
Personal legal forms and documents are stored on a secure server and are only accessible via password.

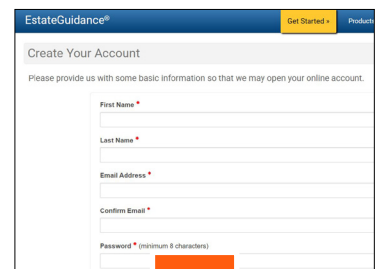
