

SUMMARY ANNUAL REPORT

This is a summary of the annual report of the Ima Group Disability, Life and Accident Plan, EIN 48-0805634, Plan No. 504, for period 01/01/2024 through 12/31/2024. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Hartford Life and Accident, Unum Life Insurance Company of America, Zurich American Insurance Company, Provident Life And Accident Insurance Company, and Headspace, Inc. to pay Life Insurance, Long-term Disability, Accidental Death and Dismemberment, Employee Assistance Program, Long Term Care, Business Travel Accident, Critical Illness, Accident, Hospital Indemnity, and Individual Disability claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2024 were \$3,384,430.
